



1. How to Enter the Contest:

- (a) The *Win a Trip to the Big Apple!* contest will begin on **November 1, 2006** and end on **midnight November 15, 2006.**
- (b) To participate in the contest one must register at the Visitor's Center Counter at the Austin-Bergstrom International Airport between November 1 - 15, 2006. The Airport Visitor's Center and Ampco System Parking will supply the entry forms.

Entries may be left during contest period at the airport's Visitor's Center during business hours Mondays-Saturdays 8am-8pm, and Sundays 10am-7pm.

**Or, customers parking at any ABIA On-Site Parking lot overnight or longer will automatically be entered into the contest during the contest promotion term (November 1-15, 2006).**

- (c) **Contest sponsors (ABIA, JetBlue Airways, Hotel Roger Williams) are not responsible for late, lost, stolen, misdirected, misaddressed, postage due or illegible entries.**
