## WASHWISE REBATE PROGRAM

The City of Austin and Texas Gas Service have joined in an effort to conserve water, gas, and electricity by offering a rebate on water and energy efficient front-loading commercial clothes washers. The WashWise Program offers rebates of up to **\$250** to customers who install a qualifying commercial machine in a common use area. The rebate is made up of two parts: a water rebate and an energy rebate. To be eligible for the \$150 water rebate, you must either be a retail water customer of the City of Austin, or get your water from a MUD that purchases water from the City. To be eligible for the \$100 energy rebate, your water heater must use gas from Texas Gas Service and have one of the following rate codes: **Austin I/S Com., Austin I/S Sm. Vol. Com A/C, Austin I/S Lg. Vol. Com, or Austin I/S Lg. Vol. Com A/C**. The installation must be for a minimum of five years. **Program guidelines and rebate amounts are subject to change.**

- Install a new, qualifying high-efficiency washer. Rebates will not be given on machines that replace existing front-load washers.
- Complete all sections of this application, except the section labeled “City Use Only”.
- Submit the following: 1) A signed Customer Agreement and completed application. 2) A copy of the purchase receipt or selected sections of the route company lease that document lease term and the name and address of the parties of record. Mail or fax to:

- Application for the rebate must be received within 30 days of initial installation or initial purchase.
- You will be called in approximately two to three weeks after receipt of your application to schedule a verification inspection.
- After successful verification inspection, you can expect a rebate check in 6-8 weeks. Texas Gas Service will send a separate check.

### CUSTOMER AGREEMENT

**In order to receive the rebate from the City of Austin, I agree to the following terms and conditions:**

1. I will keep the clothes washer(s) installed at an address within the City of Austin water service area for a period of at least five years.
2. I understand that before I receive the rebate, an inspection will be conducted. The clothes washer(s) must be installed and operating at the time of inspection.
