EFFECTIVE OCTOBER 1, 2007

- ◆ No irrigation is permitted on Monday.
- ◆ Watering days for commercial and multifamily properties are Tuesday and Friday, year round.
- ◆ The additional day options are: Wed/Sat or Thurs/Sun
- ◆ Watering hours are 12 AM to 10 AM and 7 PM to 12 AM
- ◆ Compliance with irrigation schedules is mandatory year round for commercial properties.
