Approved controllers must be installed with a rain shut-off device. They must be equipped with battery back-up, minute to minute station runtimes, multiple start times, and multiple programs. Although controllers available at home improvement stores may have the required qualifications, we do not recommend these controllers as we find them difficult to operate.
